Purpose:

Fees and Pricing:

- 1. The agreed upon price for the service is \$129.00. This price includes filming, editing and delivering 1 copy of the video via USB drive.
- 2. There is a \$49 booking deposit in order to make a reservation(hereinafter called "PAYMENT 1"). This payment can be paid via credit/debit card or Zelle. Refer to the "Cancellation:" section on page 2 for more information.
- 3. Once the film is edited and completed the videographer will inform the client to pay the remaining balance in cash or via credit/debit card or Zelle(hereinafter called "PAYMENT 2"). Only after payment 2 is completed, will the final video be delivered.
- 4. Each additional copy of the final video can be requested in a USB drive for an additional \$35.00.
- 5. The client can also request the video to be published privately to Youtube.com where it can only be visible with the valid link. The price for this service is an additional \$20.00.

Terms of Service:

- 1. In order for us to film the funeral of a decedent, the next of kin and immediate family of the decedent has to approve of our services for the funeral. By signing this agreement and hiring us, the client takes full responsibility and agrees to have received consent by the next of kin and immediate family. We are not responsible for any family conflicts.
- 2. The client agrees and understands that the rules of the cemetery and/or location of service shall be respected at all times. If the cemetery and/or location of service prohibits us to film the funeral or any section of the funeral we must respect and follow these rules. Consult with the cemetery before booking.
- 3. If we cannot perform this Agreement in whole or in part due to a fire or other casualty, acts of God or nature or terror, or other cause beyond the control of the parties or due to videographer's illness or injury, then we will return any deposits that have been paid by the client but shall have no further liability with respect to this Agreement. (Continuation from page 1)This limitation on liability shall also apply in the event that videographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the videographer.

- 4. The liability of White Dove Videography is limited to the amount paid under this agreement only.
- 5. The videographer agrees to have the fully edited film of the funeral ready in a USB drive (included in final price) within 5 days after the date and time of service.
- 6. The client agrees to give the videographer full creative control of the filming and editing process.
- 7. The client agrees that all footage is exclusively owned and a copyright of White Dove Videography. Reproduction of the final film or sections of the final film is deemed illegal without the consent of White Dove Videography.
- 8. The client gives us authorization to use the film and clips created from this service to display on our website, social media and any other platforms to promote our services.
- 9. Any verbal agreements made by both parties are not concrete unless included in this agreement.

Videography Guidelines and Disclaimers:

- 1. To ensure higher quality of video we recommend the client to advise all guests to avoid walking in front of the videographer's camera. We are not responsible for any shots being ruined due to guests interference.
- 2. The quality and duration of the final film will vary depending on the nature of the funeral, such as weather, the actual duration of the funeral, and significant events that take place at the funeral, etc.

Cancellation:

- 1. The client has the right to cancel this agreement at any-time, however the booking deposit is non-refundable unless there is a reasonable reason for canceling that is out of the clients control. We have the ultimate say to what is deemed "reasonable."
- 2. We reserve the right to cancel this agreement at any-time due to reasons out of our control such as illness, injuries or unprecedented acts of nature. We also reserve the right to cancel any filming due to harsh conditions such as heavy rain that can damage our equipment, in this case any deposits paid will be fully refunded.
